Reporting: August 2021 (Prepared on 8/28/2021)

Programming:

Summer Reading Program: Both the Adult and Kids' Reading Programs are over on September 4th. The final adult drawing was held on Friday, August 27th, and young readers have until that date to complete the reading challenge.

The Mary Wilcox Library hosted a joint "Dan the Snakeman" event with us on August 21st which featured three shows. Excluding volunteers and staff, we had 84 attendees!

Haunted Week: We are already beginning to set our sights into the fall and our Annual Haunted Week. This year's events will once again be contact-free and without indoor gatherings. Activities are in the planning phase. Preliminary dates are 10/27 - 11/1.

Technology:

The main circulation desk computer and teleconferencing center are still in discussion between Rick C and staff. Furthermore, we received good news this month – the Library will be a recipient of a tablet from 4CLS pre-loaded with Mobile WorkFlows software which will be an incredible asset for conducting curbside services and the annual weeding. These tablets are being supplied through a CARES Act granted received by 4CLS.

Policy:

The "Airborne Infectious Disease Exposure Prevention Plans" as mandated by the New York State HERO Act is still under development and should be available for Board review in the coming month.

Staffing:

Linsey Howell, who worked as circulation desk clerk from April 2018 until now, completed her final day this month. I am unspeakably grateful for all of the dedication, initiative, and energy she brought to our organization and wish her the best in all future endeavors! Raquel Howell replaces her and has received full service training.

Training:

Sexual Harassment Prevention Training has not yet been announced by FCLS. I sent an email to Steve Bachman but received no response to date. I also haven't heard anything from the Town of Lisle.

Fall Day of Learning through 4CLS will have a module focused on Confidentiality Law. With advancing technology, the System believes it is time to revisit this topic, disseminate training material to library for staff training, and for member libraries to consider implementing or updating in-house policies.
